In this way, when they graduate, the people who know them will want to go to their office to receive the criteria of a professional who provides security, confidence; from professional attitudes backed by knowledge, empathy and assertiveness towards their patients and, over time, achieve their loyalty.

For which they must constantly prepare themselves, without stopping to think trivialities but with delivery, responsibility, commitment, and above all with humanistic and fair positions.
